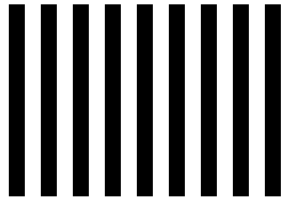

**Cleaning Guideline for Residential Trim Coil Products**

Periodic cleaning of the factory applied coating, on your aluminum trim and accessories, to remove the build up of resins and other residue, is recommended to enhance the appearance and extend coating life.

Simple washing with plain water using hoses or pressure spray equipment is usually adequate. When surfaces are dulled by heavy deposits of dirt or other contaminants, a heavy duty dry powdered laundry detergent (such as Tide) mixed 1/3 cup in a gallon of water may be used or, try a mixture of 1/3 cup of laundry detergent, 2/3 cups TriSodium Phosphate (TSP) and one quart of 5% Sodium Hypo Chlorite (such as Clorox) with three quarts of water. A long handled bristle brush will make cleaning easier. Follow cleaning operation with a clear rinse.

In areas subject to high humidity levels, mildew can occur. When heavy mildew growth is present on the surface, and the above cleaning methods are not effective, a commercially available mildew cleaner is recommended. Our testing has shown good results with Scrubbing Bubbles Mildew Stain Remover from SC Johnson, and ZEP Mildew Stain Remover from the Acuity Specialty Products Group. Cleaning should be performed in accordance with directions supplied with the cleaning product. Because of the corrosive nature of these types of products formulated for the removal of mildew, it is crucial that the area be thoroughly rinsed with clean water after cleaning. Pressure washers are extremely effective at this, as well as help remove any residual debris.

Avoid strong solvent and abrasive type cleaners. Remove any caulk compounds, oil, grease, tar, wax and similar substances with a soft cloth soaked in mineral spirits. Wipe only contaminated areas, follow with detergent cleaning and then rinse thoroughly.

# Performance G8 Trim Coil Thirty-Year Limited Warranty

Products Installed And To Be Covered By This Warranty

### Non-Prorated/Non-Transferable

#### Coverage Under This Warranty

Subject to the terms and conditions set forth in this warranty, Alside warrants that for a period of thirty (30) years from the date of installation that its Performance G8 painted aluminum trim coil ("Products") will be free of manufacturing defects and will not peel, chip, blister, flake, or crack when used as intended and under ordinary conditions. This warranty does not cover crazing or slight cracking which may occur on tightly roll formed edges, break bends of severe embossing or which is otherwise considered industry standard and only applies to Products installed in the fifty (50) United States and the District of Columbia.

#### What You Should Do In The Event Of A Defect

If your Products exhibit a defect covered by this warranty, write to Alside, PO Box 2010, Akron, OH 44309, describing the defect and providing your name, property address, date of installation, a copy of this certificate and a copy of the invoice showing the actual purchase price. Alside will refinish, replace or repair the defective Product or, at Alside's sole option, will refund the purchase price paid for the actual defective Product. Alside will perform its obligations under this warranty, weather permitting, within a reasonable time after receipt of notice of defect. Alside reserves the right to inspect the Product(s) claimed to be defective within a reasonable period of time after it receives your claim.

#### Conditions Not Covered By This Warranty

This warranty does not include re-installation of Products or Product defects occurring as a result of faulty installation. It covers only the specific manufacturing defects described herein and excludes any other defects or failures including, but not limited to, failure to provide normal maintenance and cleaning to remove dirt and mildew; damage resulting from accident or casualty, acts of God, vandalism or wind-blown objects; damage caused by corrosive or aggressive atmospheres such as those contaminated with chemical fumes or salt spray, either directly applied or in the atmosphere; or by coming in contact with dissimilar materials such as, but not limited to, treated lumber, stucco, concrete, or other

materials. Uniform fading and color change are not considered to be a Product defect because normal weathering and aging will most likely cause any painted aluminum surface to fade, darken, chalk or acquire a surface accumulation of dirt and stains. The severity of these conditions depends on air quality, the geographic location of your property and other local conditions over which Alside has no control. Normal weathering is defined as exposure to sunlight and extremes of weather and temperature. Non-uniform fading and color change resulting from unequal exposure of the painted aluminum building products to the sun and elements are not covered by this warranty.

#### Remedies Under This Warranty

THE WARRANTY STATEMENTS CONTAINED IN THIS LIMITED WARRANTY SET FORTH THE EXPRESS WARRANTIES EXTENDED BY ASSOCIATED MATERIALS INCORPORATED AND ARE IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED. THE PROVISIONS OF THIS WARRANTY SHALL CONSTITUTE THE ENTIRE LIABILITY OF ASSOCIATED MATERIALS INCORPORATED AND SHALL BE THE PROPERTY OWNERS EXCLUSIVE REMEDY FOR BREACH OF THIS WARRANTY. ASSOCIATED MATERIALS SHALL NOT BE LIABLE TO THE PROPERTY OWNER FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES OF ANY KIND FOR BREACH OF ANY EXPRESS OR IMPLIED WARRANTY.

Some states do not allow the exclusion or limitation of implied warranties and incidental or consequential damages so the above limitations may not apply to you. This warranty gives you specific legal rights and you may also have other rights which vary from state to state.

Alside reserves the right to discontinue or change any Products. If for any reason the Product originally installed is not available at the time of the defect and Alside elects to replace the defective Products, Alside will have the right to substitute with painted aluminum building products determined by Alside to be of equal quality and price. The original warranty will not be extended by any warranty repairs.

#### Registration Of Warranty Coverage

The attached Registration Card should be completed and signed by the Contractor and the Owner of the Product and mailed to Alside after installation has been completed.

This card and the attached Warranty Certificate are to be filled in and signed by both the Performance G8 Dealer and property owner(s). Mail only this card to Alside after installation has been completed. Your Thirty-Year Limited Warranty will be registered, but will not be acknowledged unless requested.
